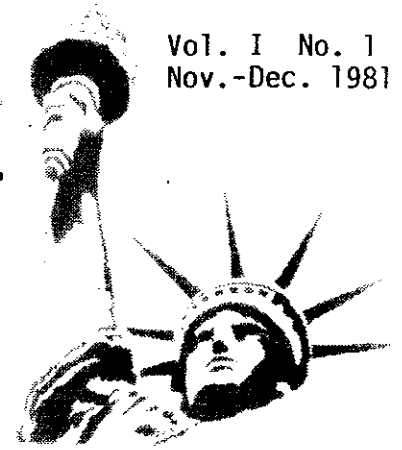

MICHIGAN ALERT

Bellaire

A three member committee of fundamentalists requested the Bellaire local school board in April to include scientific creationist textbooks in their curriculum to present creationist theory as an "alternative" to evolution. After studying the issues school superintendent Gary Wright recommended the inclusion of these materials for library reference but not for classroom use.

Genesee County

In similar action a Fundamentalist science teacher in Clio convinced the school board, with the help of his principal, to purchase new textbooks sponsored by the Institute for Creationist Research in the spring of this year. The school board reviewed the thirty new books in preparation for their use for this fall and found them unacceptable and the books have been placed into reference in the library.

Genesee County

The Reverend David Wood, head of the Michigan chapter of the Moral Majority recently visited Flint, Mich. for a television interview on Flint channel 12 and for a newspaper interview with Betty Brenner, religion editor of the Flint Journal. His stated goal is to form a local branch of the Moral Majority for every precinct in Genesee County (twelve chapters).

Essexville

The New Right recently formed a parents' group devoted to protecting "basic" family values. The group, called "Steps Toward Exerting Parental Supervision (STEPS)", has targeted sex education for elimination from several school systems in the tri-City area. The Essexville case has been satisfactorily resolved by a poll conducted by school board personnel that showed most parents desire a continuation of the present program, contrary to the claims of the new right. While the situation seems to have quieted in Essexville, pressure continues to be brought to bear in surrounding districts, primarily due to the efforts of Betty Lewis, vice president of the Michigan Alliance of Families. This pattern makes one wonder whether the controversies are isolated incidents or are coordinated.

Flint

The Flint area, termed by Howard Simon of the American Civil Liberties Union to be the "book ban capitol" of Michigan, has been the site of numerous censorship attempts. According to The Flint Voice, Aug. 21, 1981, most of these attempts have been unsuccessful, but a few have resulted in the permanent and temporary banning of small numbers of materials from Genesee County libraries.

On August 13, 1981, the Genesee District Library Board rebuffed a small group of citizens whose list of prospective banned books, purportedly "tainted by humanism", had grown to over 30. After several meetings with the book-banners, the library board moved to dismiss the self-appointed censors and to maintain the current list of library materials, thus abiding by American Library Association guidelines.

PENDING MICHIGAN LEGISLATION

Lansing

House Bill #4017, otherwise known as the "school prayer" bill, would require local school districts to set aside time for so-called "voluntary" prayer. The bill is currently pending in the House Education Committee. VOR President Lynne Silverberg, State Secretary Howard Simon, and State Action Committee Chairperson Eli Master met with Lucille McCollough, Chairperson of the House Education Committee in early September. Religious leaders and professional educators were also present. Ms. McCollough recommended a letter be written to each committee member. The VOR's letter recommended the bill be referred to a special subcommittee for determination as to its constitutionality.

NETWORK OF SCIENTISTS

The Michigan-based Voice of Reason Science Committee, headed by Laurence Levine, is joining a national network of scientists dedicated to improving the quality of public school classes in evolutionary biology. The network of scientists, which to date involves eighteen states, intends to resist the intrusion of creationism into science curricula.

One arm of the network, the Michigan Committee of Correspondence, is mobilizing Michigan teachers against the impending invasion of creationists

into the teaching of science. Dr. Carl Bajema of Grand Valley State Colleges has been instrumental in the formation of the Michigan Committee of Correspondence. Dr. Mark Weiss of Wayne State University has agreed to act as the committee's contact with the national network. Michigan teachers are receiving information from experts in anthropology and biology. Professional scientists will give expert testimony before public school teachers and school boards that are under creationist pressure.
